PER CURIAM:

Aaron Riley appeals the district court's order dismissing his motion under 28 U.S.C. § 2255 (2000) without prejudice, redocketing his Petition for Declaration of Nationality as titled and denying the same, and denying his Writ of Coram Nobis.
