PER CURIAM:

Launeil and Janneth Sanders appeal the district court's order accepting the recommendation of the magistrate judge and dismissing Sanders' 42 U.S.C. § 1983 (2006) complaint against Prepaid Legal, Inc and denying Sanders' motion for leave to file another complaint against Prepaid Legal, Inc.
