Leopold O. V. Enwonwu appeals the district court's order accepting the recommendation of the magistrate judge and denying relief on his 42 U.S.C. §§ 1981, 1983, and 1985 (2006) complaint. We have reviewed the record and find no reversible error. Accordingly, we affirm for the reasons stated by the district court. Enwonwu v. Branch Banking & Trust Co., No. 3:10-cv-00858-CMC (D.S.C.
