Ronnie G. Arnold appeals the district court's order granting Defendants' summary judgment motion on his age discrimination claim, brought pursuant to the West Virginia Human Rights Act, W. Va. Code Ann. §§ 5-11-1 to 5-11-20 (LexisNexis 2011). We have reviewed the record and find no reversible error. Accordingly, we affirm the district court's judgment. See Arnold v.
