

**DIRECTIONS TO
NORTH CAROLINA CENTRAL UNIVERSITY
SCHOOL OF LAW**

From Downtown Durham via the Durham Freeway/Hwy. 147 South:

- 1) Take the Alston Avenue exit (Exit 11) and turn right at the end of the exit.
- 2) Go to the 3rd stoplight (at Burger King) and take a right onto Cecil St. (You will see the Turner Law Building on your immediate right).
- 3) To get to the front of the Turner Law Building, go to the first stop light and take a right onto Lincoln St.; go about 50 yards and take the first right. Drive down the hill about 75 yards to the School of Law which is on your right.

From the Research Triangle Park via the Durham Freeway/Hwy. 147 North:

- 1) Take the Alston Ave. exit (Exit 11) and turn left at the end of the exit.
- 2) Go to the 4th stoplight (at Burger King) and take a right onto Cecil St. (You will see the Turner Law Building on your immediate right).
- 3) To get to the front of the Turner Law Building, go to the first stop light and take a right onto Lincoln St.; go about 50 yards and take the first right. Drive down the hill about 75 yards to the School of Law which is on your right.

From Raleigh and RDU Airport via I-40 West:

1. Take the Durham Freeway North (Hwy 147) exit.
2. Go about 5 miles and take the Alston Ave. exit. (Exit 11) and turn left at the end of the exit.
3. Go to the 4th stoplight (at Burger King) and take a right onto Cecil St. (You will see the Turner Law Building on your immediate right.)
4. To get to the front of the Turner Law Building, go to the first stop light and take a right onto Lincoln St.; go about 50 yards and take the first right. Drive down the hill about 75 yards to the School of Law which is on your right.

From Chapel Hill via I-40 East:

1. Take the Hwy. 54 & 55 exit from I-40 East. (This is the 2nd exit for Hwy. 54 that you will see.)
2. At the end of the exit take a left onto Hwy. 55. This will turn into Alston Ave.
3. Go about 5 miles (You will see a Burger King.) and take a left onto Cecil St. (You will see the Turner Law Building on your immediate right.)
4. To get to the front of the Turner Law Building, go to the first stop light and take a right onto Lincoln St.; go about 50 yards and take the first right. Drive down the hill about 75 yards to the School of Law which is on your right.

From Henderson and Richmond, VA via I-85 South:

- 1) Take the Avondale Ave. Exit and turn left.
- 2) Go through 2 stoplights and bear right onto Alston Ave.
- 3) Travel through several stoplights at Geer St., Dowd St., Holloway St., Liberty St., Main St., and Angier Ave.
- 4) After crossing over Angier Ave. go to the 5th stoplight (at Burger King) and take a right onto Cecil St. (You will see the Turner Law Building on your immediate right).
- 5) To get to the front of the Turner Law Building, go to the first stop light and take a right onto Lincoln St.; go about 50 yards and take the first right. Drive down the hill about 75 yards to the School of Law which is on your right.

From Greensboro/Charlotte via I-85 North:

- 1) Take the 15-501/Durham Freeway (NC-147 South) exit (Exit 172) towards Durham/Downtown/Research Triangle Park and merge onto NC-147 South.
- 2) Take the Alston Ave. exit (Exit 11) and turn right at the end of the exit.
- 3) Go to the 3rd stoplight (at Burger King) and take a right onto Cecil St. (You will see the Turner Law Building on your immediate right.)
- 4) To get to the front of the Turner Law Building, go to the first stop light and take a right onto Lincoln St.; go about 50 yards and take the first right. Drive down the hill about 75 yards to the School of Law which is on your right.
