

**Schedule of Fees for the U.S. Court of Appeals for the Fourth Circuit**  
effective September 18, 2007, pursuant to 28 U.S.C. foll. § 1913

No fees under 28 U.S.C. foll. § 1913 are charged for services rendered on behalf of the United States, with the exception of those specifically noted below. No fees are charged to federal agencies or programs which are funded from judiciary appropriations, including, but not limited to, agencies, organizations, and individuals providing services authorized by the Criminal Justice Act, 18 U.S.C. § 3006A, and Bankruptcy Administrator Programs.

Docketing Fee for Petition for Permission to Appeal under 28 U.S.C. § 1292(b) ( <i>fee does not apply to United States</i> )	No fee shall be charged for the docketing of a petition for permission to appeal under 28 U.S.C. § 1292(b) unless the appeal is allowed, in which case \$450 shall be paid to the Clerk, U.S. District Court
Filing Fee for Appeal from U.S. Tax Court ( <i>fee does not apply to United States</i> )	\$450 payable to Clerk, U.S. Tax Court, 400 Second St., N.W., Washington, D.C. 20217

In addition to the exemption afforded to programs funded through Judiciary appropriations (including exemptions to persons providing services under the Criminal Justice Act), the Court may, upon a showing of cause, exempt indigents, bankruptcy case trustees, individual researchers associated with educational institutions, courts, section 501(c)(3) not-for-profit organizations, court-appointed pro bono attorneys, and pro bono ADR neutrals from payment of electronic access fees.
