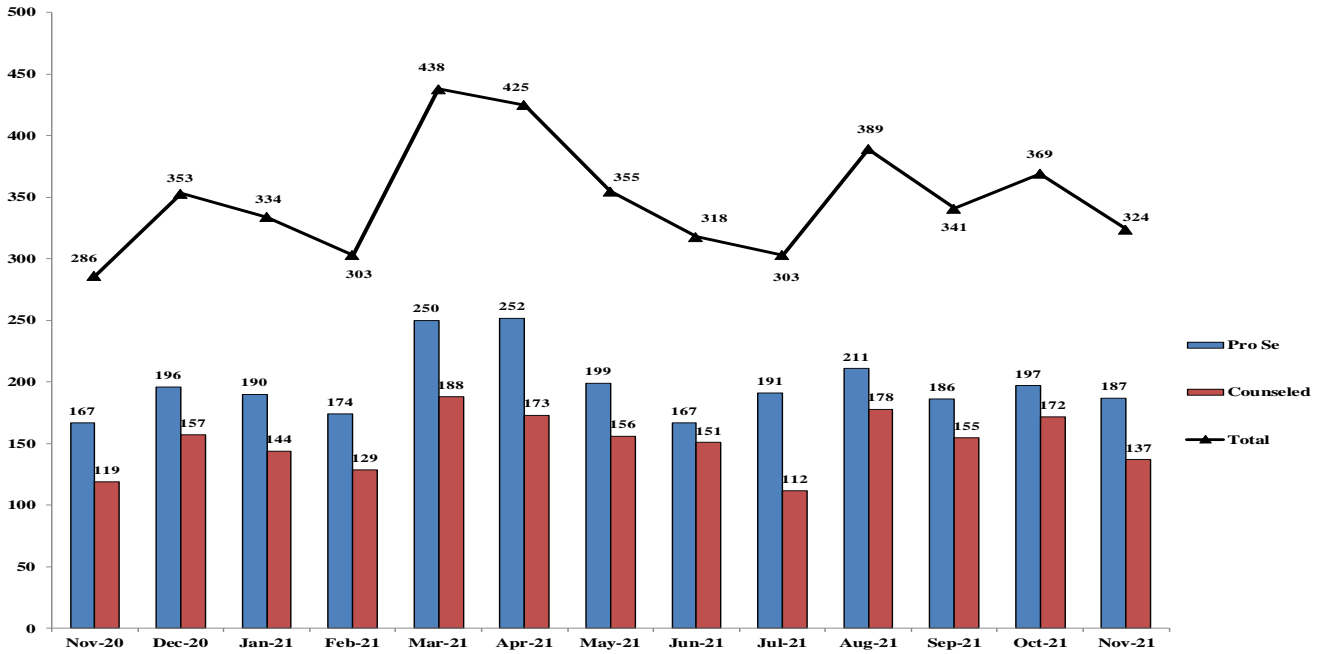

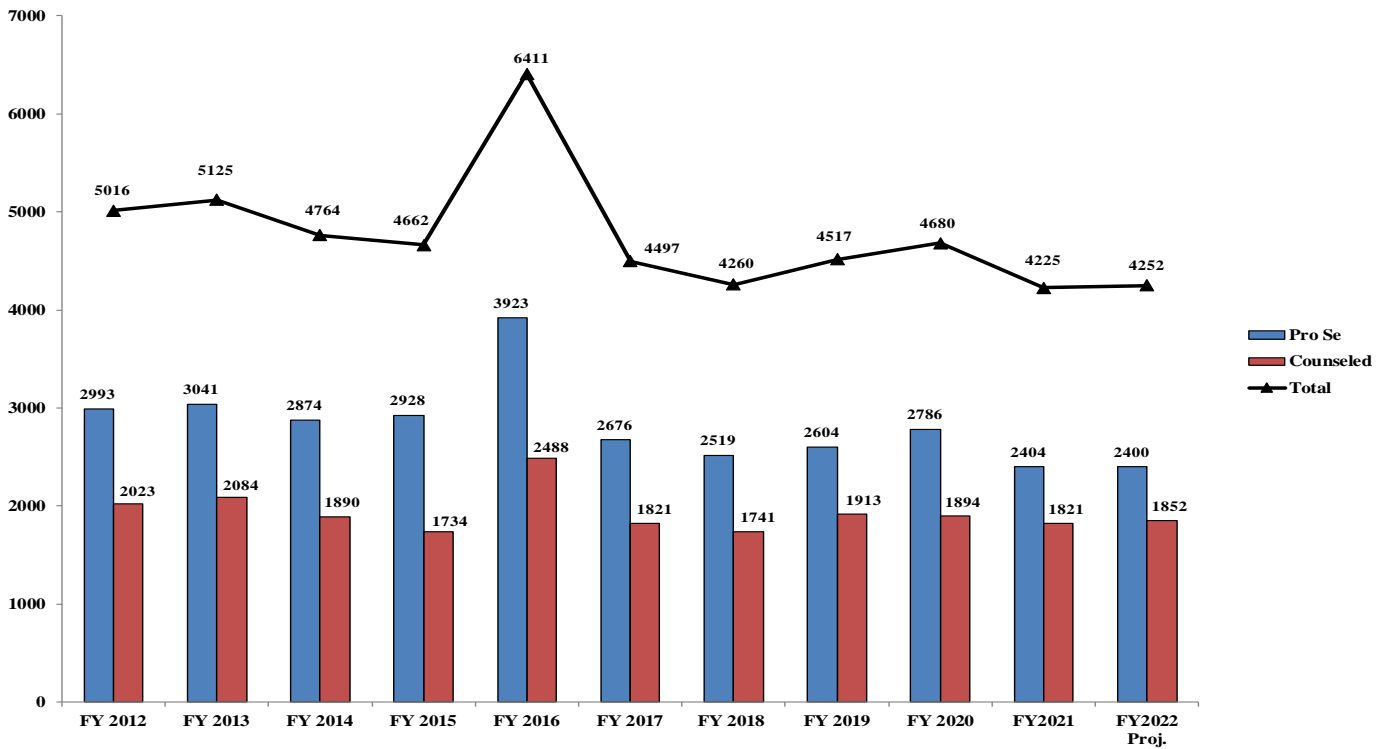

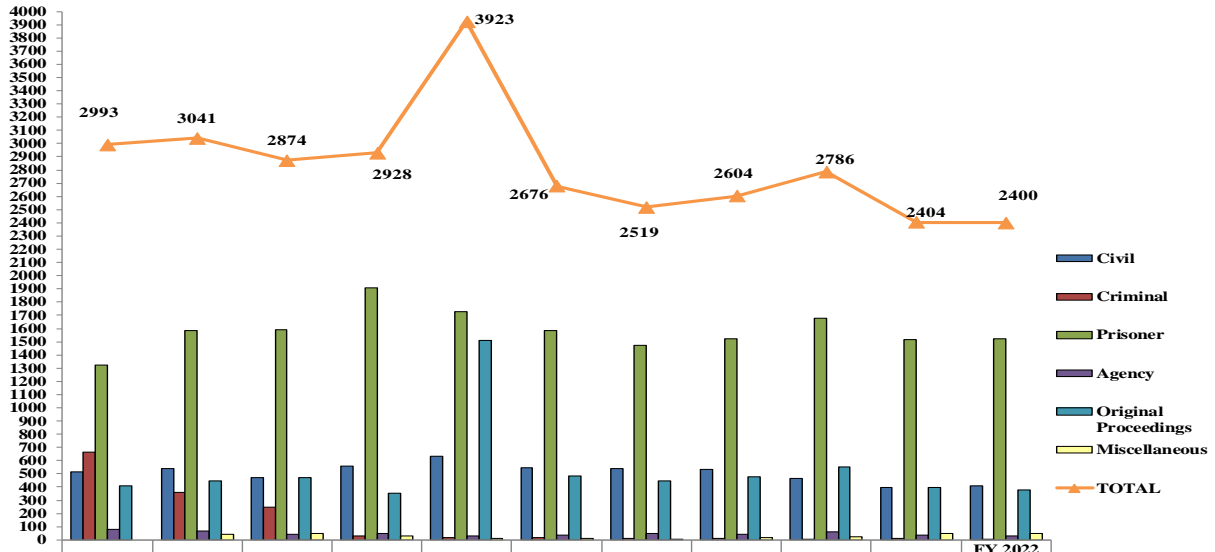
Monthly Pro Se and Counseled Case Filings

Projected Through Fiscal Year Ending September 30, 2022

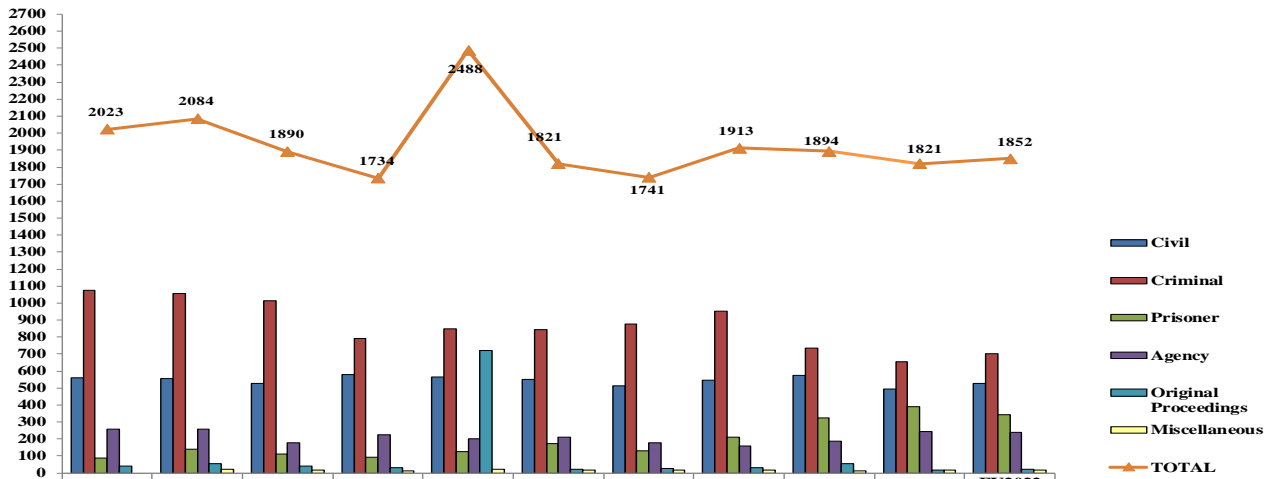

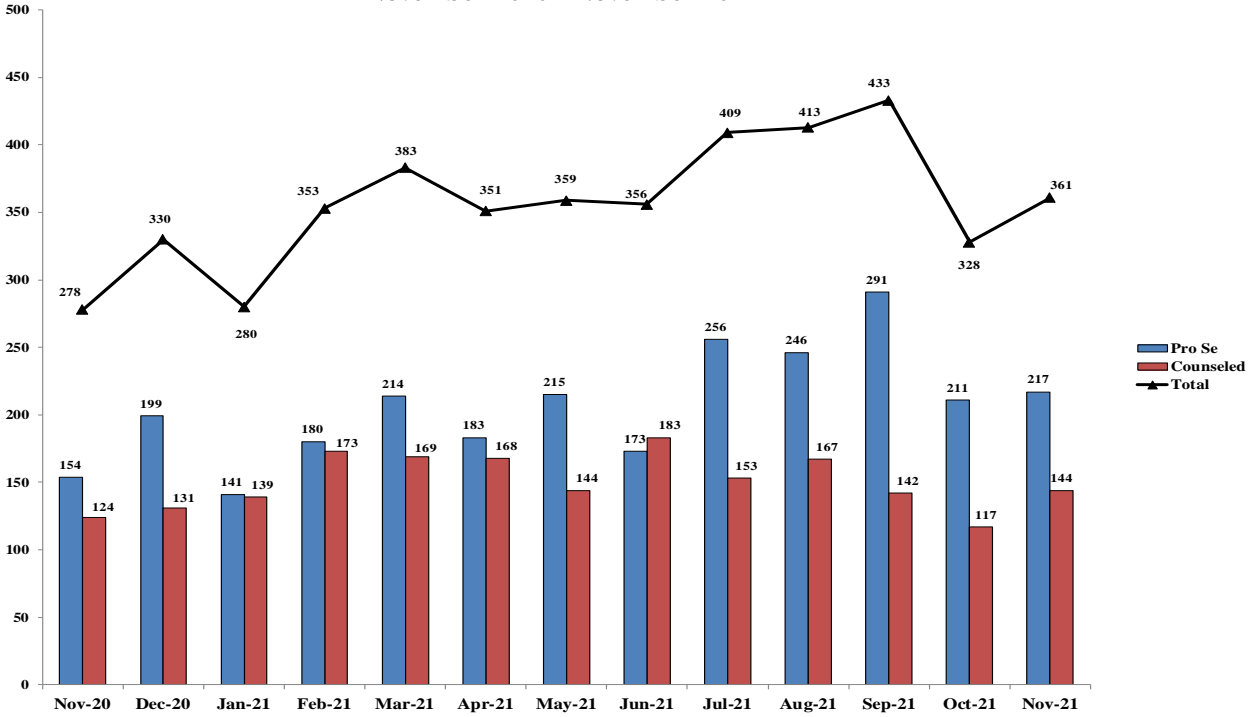
**Annual Counseled Filings by Case Type
Projected Through Fiscal Year Ending September 30, 2022**



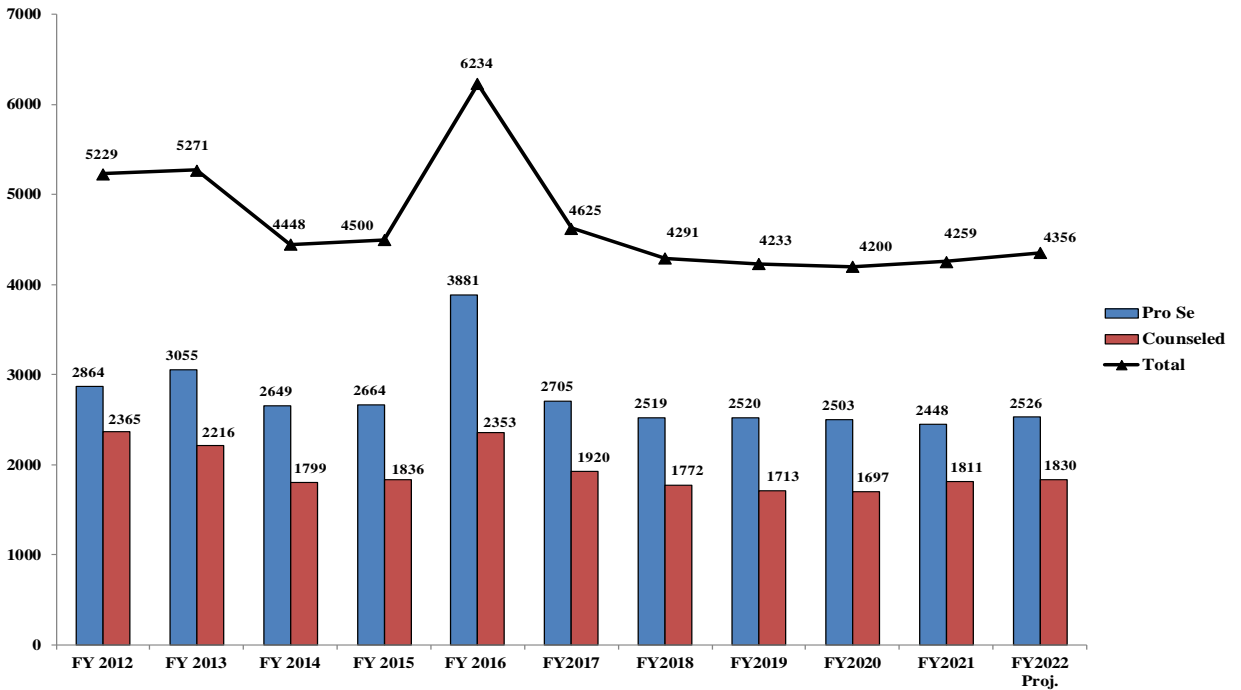

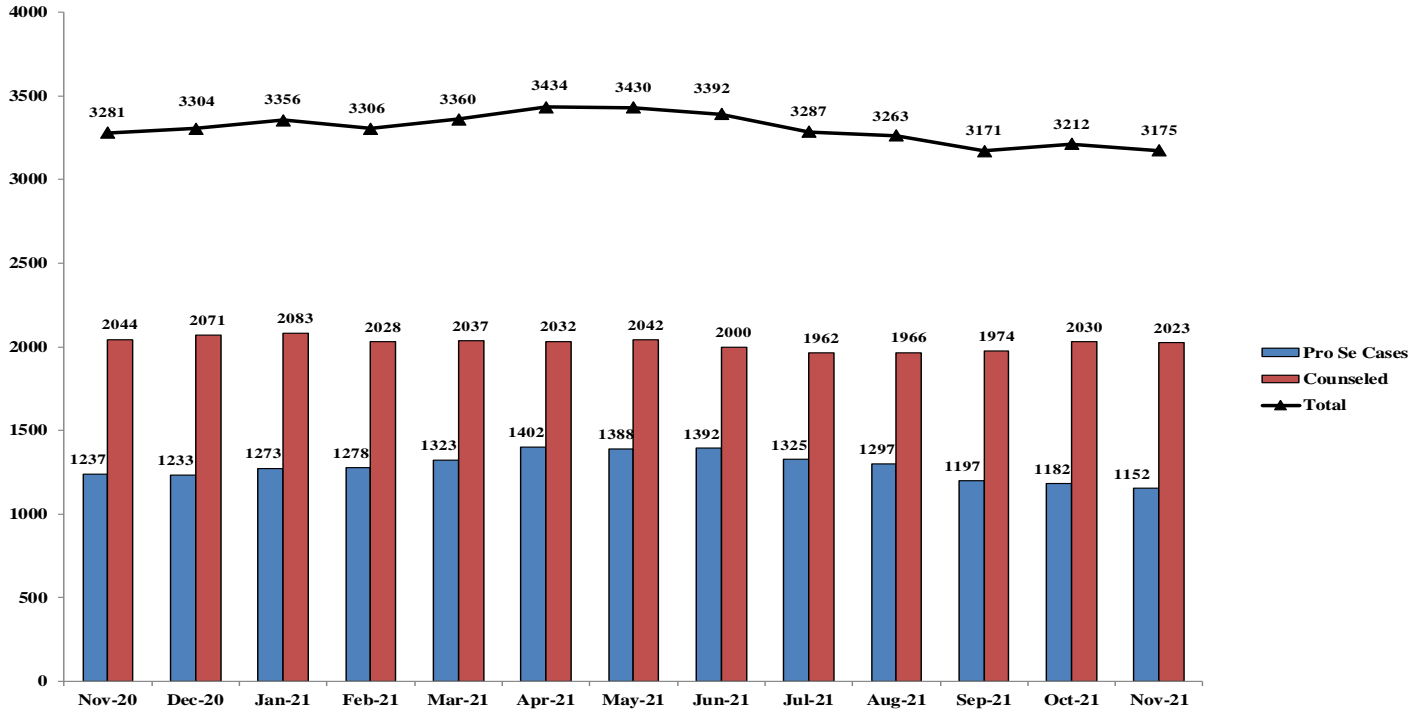


Annual Pro Se and Counseled Case Dispositions
Projected Through Fiscal Year Ending September 30, 2022

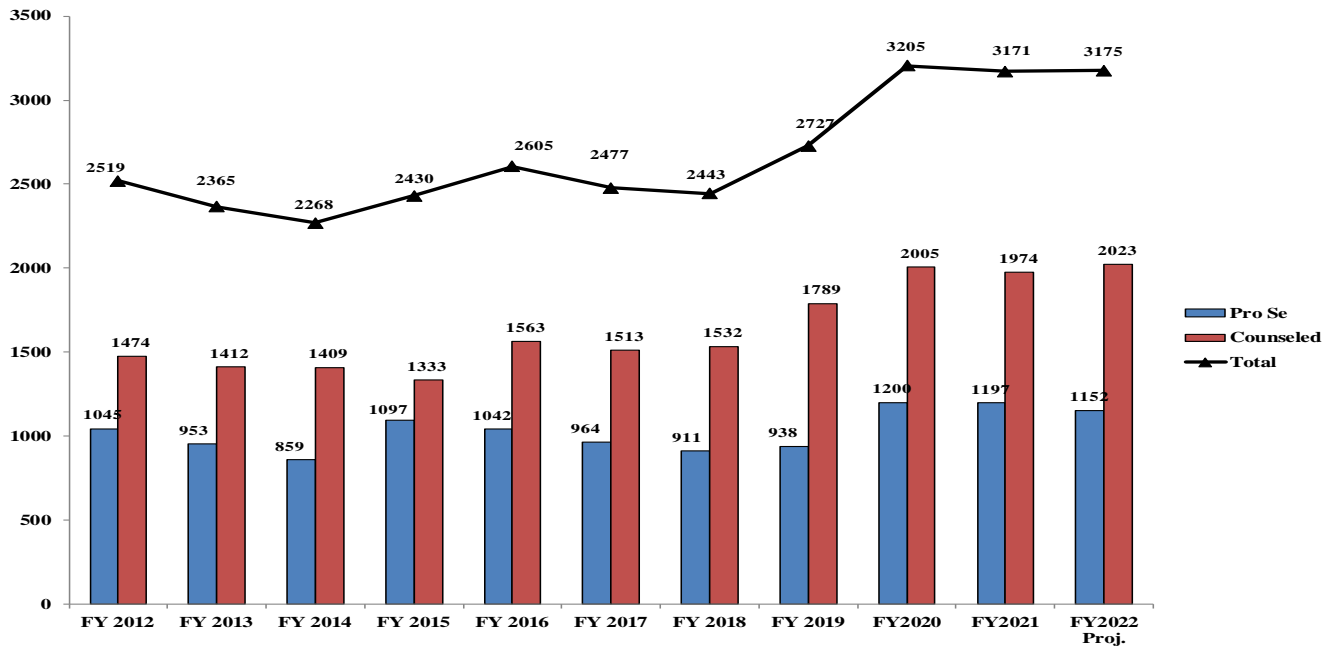
